Florida Department of Veterans Affairs (FDVA) Alwyn C. Cashe State Veterans Nursing Home at Lake Baldwin, Orlando

Come to our January 13th luncheon and meet Kat Perry-Huff, the Director of the Florida Department of Veterans Affairs (FDVA) Alwyn C. Cashe State Veterans Nursing Home at Lake Baldwin. We are fortunate to live in Florida where in addition to having VA Nursing Homes for our veterans, the FDVA operates 9 Nursing Homes throughout Florida for our veterans. Kat will give an overview of the FDVA nursing homes and entertain questions about the ins/outs of getting our veterans admitted. Legislation was just passed that if both the veteran and spouse require a nursing home by their doctor, they can reside together at an FDVA Nursing Home.

The FDVA Nursing Home in Lake Baldwin just celebrated their 3rd anniversary and was named in honor of the late Sgt. First Class Alwyn C. Cashe, a U.S. Army Medal of Honor recipient who grew up in nearby Oviedo. The 112-bed skilled nursing facility is a former VA Community Living Center and was remodeled from top to bottom to reflect state-of-the-art amenities for our veterans. The 112-bed facility offers skilled nursing care and can accommodate 32 residents with dementia/Alzheimer's disease.

The Florida Department of Veterans' Affairs operates eight skilled nursing facilities and one assisted living facility in Florida. All facilities are licensed by Florida's Agency for Health Care Administration and inspected annually by AHCA and the U.S. Department of Veterans Affairs. The homes are supervised around the clock by registered and licensed nurses. Basic

admission requirements for all State Veterans' Homes include an honorable discharge, Florida residency, and certification of need of assisted living or skilled nursing care as determined by a VA physician. Eligible spouses of Florida Veterans may now be admitted into State Veterans' Homes on a space available basis. For more information, call (407) 741-4614. Networking 38,000 MOAA members in Florida to 4,000 members in 36 chapters—Our State now speaks with One Powerful MOAA Voice! The Florida Council is leading a groundbreaking initiative to strengthen the MOAA enterprise, amplify our grassroots advocacy, enhance philanthropy and community service, and support chapter recruiting.

MOAA's leadership approved this concept nearly two years ago, and this month they provided the Council with the final piece to create the network—the database of all MOAA members in Florida. Until now, the Council has communicated primarily with chapters and the members affiliated with them. We can now communicate directly with ALL MOAA members in the state. This statewide "Community of Interest" of like-minded MOAA members serves to greatly expand our work on behalf of veterans, the currently serving military, and their families. Our vision for the Virtual Network focused on expanding and modernizing our online "virtual" presence through key investments: Over the last few years, we upgraded our website

(www.FLMOAA.org), established a strong social media footprint (Facebook, LinkedIn, Instagram, and YouTube), and acquired mass-communication tools (Zeffy and Zoom). Putting these tools together allows us to deliver timely and relevant information to our expanded member base and other veterans in the state to support MOAA national and our State advocacy efforts, as well as philanthropic and community service initiatives benefiting veterans, service members, families, and military-inclined students. A key goal is also to inform non-chapter MOAA members of the value added of local chapters and encourage their local participation and aid in the recruitment of chapter members. The first major milestone in building this network is happening now—for the first time, all 38,000 MOAA members in Florida are receiving this edition of our bi-monthly newsletter, *The Council Communiqué*! While the Council's role has expanded and is at center stage, Chapters remain key elements of the Virtual Network, serving as the “boots on the ground” and the face of MOAA in their communities. As we implement the network, we are actively collaborating with chapters to also strengthen their virtual presence so they can fully function as key nodes within this statewide MOAA virtual community of interest.

Legislative Advocacy Priorities for 2026:

While MOAA hasn't published a formal 2026 advocacy agenda document yet, ongoing priorities from its Advocacy in Action campaigns and legislative work will carry forward into the New Year. These include major national issues MOAA continues to push on Capitol Hill.

Key Legislative and Advocacy Focus Areas:

Military spouse employment: Supporting the Military Spouse Hiring Act to expand hiring incentives for military spouses by adding them to the Work Opportunity Tax Credit (WOTC).

Improved health care access: Pushing for navigation systems in the Military Health System to reduce barriers to care for service-members and families.

Toxic exposure reform: Continuing to advocate to “end the wait” for toxic-exposed veterans to receive benefits and care

Military housing oversight: Advocating for transparency and reporting requirements to improve conditions and accountability.

Caregiver support: Supporting legislation such as the Veteran Caregiver Re-Education Reemployment, and Retirement Act.

These issues are currently in progress and will likely be sustained advocacy themes for 2026, as MOAA prepares to engage with the 119th Congress. In addition, MOAA is actively tracking FY 2026 National Defense Authorization Act (NDAA) outcomes — including pay raises, PCS expenses, and health care protections — and pushing for final enactment and implementation of provisions important to its members.

Did you know that February 4th is USO Day?

USO Day celebrates the efforts of the United Service Organizations who have been supporting our service members since 1941 while they are deployed and at home. The mission statement of the USO is to “strengthen America’s military service members by keeping them connected to family, home, and country, throughout their service to the nation” (The organization).



The USO has adapted over the years and currently has many programs to support troops and their families, including providing deployed service members with care packages with comforts of home, entertainment with celebrity tours, and free Wi-Fi centers to call loved ones back home. When a service member is transitioning out of the military, the USO is there to help them navigate civilian life by offering one-on-one support to develop clear plans and hosting workshops and networking events for service members and their spouses. The USO also understands the great sacrifice children and spouses of service members make. On top of connecting families to their deployed loved ones through phone calls and hosting spouse networking events, the USO strengthens communities by providing virtual and in-person programming, including baby showers, coffee connections, reading programs, and more. You can celebrate USO day and support our troops by visiting the USO’s website to learn more about the organization, donating, or signing up to be a volunteer.

Orlando has a USO Center! It is at the Orlando International Airport, on the ground (1st) floor, Terminal A, west end (all the way to the right of the rental car counters). Hours are 0800-2000 every day of the year!

USO centers are available for the comfort and convenience of **currently serving military personnel and their dependents**. All U.S. military personnel (Active Duty, Reserve and Guard) and their dependents with valid U.S. Department of Defense ID cards may utilize USO centers. In addition, U.S military retirees with valid U.S. Department of Defense ID cards (and their dependents with valid U.S. Department of Defense ID cards) may enter and utilize USO centers. Gold Star Families/Families of the Fallen and their guests may enter and utilize USO centers. Military dependents under the age of 18 must be accompanied and supervised by a parent/guardian.

While the USO values the service of other U.S. military constituent groups, including veterans, 100% disabled veterans, and other members of the uniformed services, these groups are not permitted access to USO centers as the primary purpose is to support currently serving military personnel and their dependents.

Roadrunner Email Update: Statewide Impact for Florida Members

Do you still use an email ending in @cfl.rr.com, @tampabay.rr.com, @fl.rr.com, @rr.com, or @roadrunner.com? These legacy accounts were originally created through Bright House and Time Warner Cable and are now managed by Spectrum. Across Florida, parts of the old Roadrunner system are being phased out, and reliability is declining.

What's Happening?

Statewide, Spectrum has:

- stopped issuing new Roadrunner-style addresses
- begun retiring or consolidating older servers
- tightened security systems
- shut down some accounts when customers cancel Spectrum internet

As a result, email delivery is becoming less dependable—especially for organizations sending group communications.

Why It Matters

Chapters across Florida are reporting:

- increased email “bounce-backs”
- members not receiving newsletters or event notices
- difficulty connecting Roadrunner accounts to Outlook, Apple Mail, or smartphones • unexpected loss of inbox access

If a Roadrunner address becomes inaccessible, members may lose important contacts, messages, and password recovery access for banks, medical portals, and government accounts.

What Members Should Do

You do not need to abandon your Roadrunner address immediately but now is an excellent time to prepare.

1. Create a new, reliable email account. Gmail, Outlook.com, Yahoo, or similar services are free and well-supported.
2. Update important accounts gradually. Banks, medical portals, Social Security, recurring bills, and chapter records.
3. Save or forward key messages. Back up important emails and contacts.
4. Keep checking your old address. Continue monitoring it for updates while it remains active.

Very Important: If you change your email address, please update your information with MOAA (Military Officers Association of America) and your local chapter to ensure you continue receiving newsletters, event notices, and legislative updates.

Bottom Line

This transition affects all Florida members, not just those in Central Florida. Legacy Roadrunner email addresses may stop working with little notice, leading to missed chapter
